When Should You WINTERIZE?

Don't wait for snow and frigid temperatures to get your apparatus ready to face the elements. **GLICK's** four service locations across Pennsylvania can get you ready for the harsh winter elements.

Here are some important maintenance items to consider before the colder days ahead:

1. Check the Coolant – Levels should be checked and the appropriate mix should be used to protect against freezing. Check for possible damage or leaks in the system.

2. Heater and Defroster Check – Are the heater and defroster both in working condition? Check that you're getting sufficient airflow from your defrosting system and that the hot and cool air work accordingly. The rig may start, but if you can't see the road you won't be arriving on scene anytime soon.

3. Check the Battery – Battery faults are most common in the winter months when cold weather puts a major drain on your apparatus battery's starting power. Make certain the terminal connections are clean and free of corrosion or damage. Another good point to test would be the charge level. With the huge drain on the battery in the wintertime, you want to be sure the alternator is doing its job properly

4. Inspect Tires – Confirm your tires are ready to handle winter's hazardous road conditions: check the



tread thickness and inspect the tires for proper inflation, cracking or rot. If automatic tire chains are installed, clean any road dirt they may have picked up over the months of non-use. Proper placement and operation of your tire chains is essential in your ability to respond in a safe manner.

Of course, any of **GLICK's** service departments or mobile service units can perform these maintenance items as well.

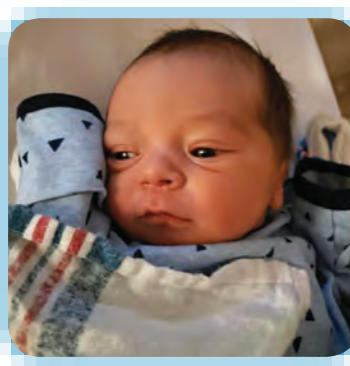
