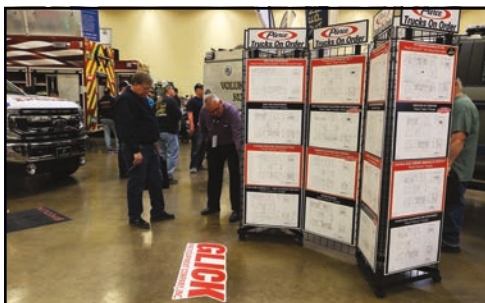
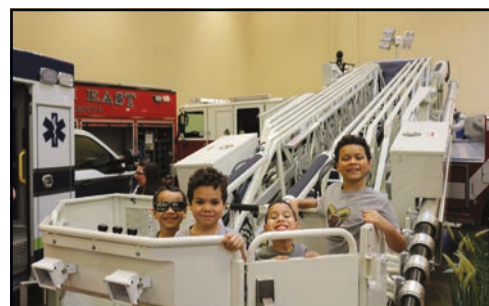

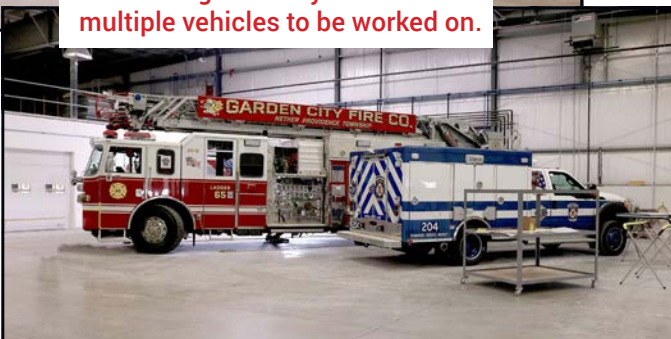
## LANCASTER COUNTY FACILITY, BIRD IN HAND
